

**The Jordan Trail Association (“JTA”)**  
**Changes, Cancellation, & Refund Policy**

This Cancellation and Refund Policy (“**Policy**”) applies to the Thru-Hike event which is scheduled to take place on the 09<sup>th</sup> of October 2026.

### **Changes**

The JTA will endeavor to apply the arrangements described in our website and brochures to the extent possible. We plan the arrangements for the Thru-Hike event months in advance and may occasionally have to make minor changes. The JTA reserves the right to change the dates, itinerary, schedule, facilities, services, transport, and overnight arrangements (hotel, homestay or camping arrangements) described in our website and brochure at any time before or during the Thru-Hike event.

The choice of overnight arrangement will always be subject to availability and may change to accommodate the number of participants, or due to weather conditions or other circumstances.

The JTA will inform you of any change to the itinerary or services described in our website and brochure as soon as reasonably possible.

### **Force Majeure**

There are many conditions or events that are beyond our control including, but not limited to, potential or actual adverse weather conditions, natural disasters, fire, epidemics or pandemics, health risks, trail situations, bans by governments or official authorities, acts of God, riots, civil disturbances, legislative changes, unavoidable or unforeseeable technical problems with transport and other circumstances that amount to a ‘**Force Majeure Event**’.

In case of a cancellation due to a Force Majeure Event, you will have the choice of:

- a. receiving a full refund minus an amount of JOD 100<sup>1</sup> of the total fee paid by you and any costs that are non-refundable by other service providers, hotels, and transport providers; or
- b. transfer to the next scheduled Thru-Hike.

## Cancellation and Refund

### 1- Cancellation by the JTA

- c. The JTA reserves the right to cancel the Thru-Hike event at any time prior to its starting date, at a date it deems least convenient for the participants. The JTA will notify the participants of the cancellation and the reasons for such cancellation as soon as possible.
- d. In this case, an amount of JOD 100<sup>2</sup> of the total fee paid by each participant will serve as a non-refundable deposit and the remaining amount will be refunded.
- e. JTA requires a minimum of ten participants to run the Thru-Hike event to ensure a meaningful experience for the group. If JTA does not receive this minimum amount within 14 days of the start date of the Thru-Hike, the JTA has the right to make the unfortunate decision to cancel or re-schedule the event. In this case JTA will fully refund the cost of the event and will inform you of the cancellation by email.

### 2- Cancellation by you:

Should you cancel your participation in the Thru-Hike, the following guidelines apply:

- a. **90 days before the start date of the Thru-Hike:** you qualify for a full refund, minus an amount of JOD 100<sup>3</sup> of the total fee paid which will serve as a non-refundable deposit.
- b. **60-89 days before the start date of the Thru-Hike:** you are eligible for a 50% refund, minus an amount of JOD 100<sup>4</sup> of the total fee paid which will serve as a non-refundable deposit.
- c. **59- 20 days before the start date of the Thru-Hike:** you are eligible for a 25% refund, minus an amount of JOD 100<sup>5</sup> of the total fee paid which will serve as a non-refundable deposit.
- d. **19 days or less before the start date of the Thru-Hike:** your trip is non-refundable.

## Exchange Rate and Transfer Charges

Refunds for bookings, based on this Policy, will be refunded to the nominated credit card used to pay for the original booking. All refunds will be made in Jordanian Dinars. If you paid by credit card denominated in a foreign currency, the refunded amount you receive in your foreign currency may not be exactly what you were charged at the time of booking due to changes in the foreign exchange rates, non-refundable or additional bank or credit card
